The guest speaker was James Hochberg, a Honolulu attorney and founder and president of the Hawaii Family Advocates (HFA). He briefly outlined the mission of the organization and his particular role. Charitable organizations such as the Hawaii Family Forum and our Guild are 501(c)(3) and as a result donations are tax deductible. In addition, the I.R.S. places severe restriction on what 501(c)(3) organizations can say and do when it comes to public policy. That's why the HFF board of directors in 2010 created Hawaii Family Advocates as a 501(c)(4) with the intention of working along side Hawaii Family Family Forum policy interests without the restrictions of a 501(c)(3). Mr. Hochberg is very optimistic that together with the Guild we can assist and aid candidates for public office who share our values.

Raphaela Lukan, our Treasurer, ensured the Federal Taxes for 2013 were completed by a CPA and filed as required, as well as the General Excise Tax (GET) for 2013.

## Historian

Progress is ongoing in determining the exact location of the Catholic chapel built in the area of Kapi'olani Park of 1898. Mrs. Cowes, the Guild's Vice-President in 1898, canvassed the city for funding the construction of a small chapel in Waikīkī to give the soldiers of the First Regiment of New York Volunteers an opportunity for attending Mass. According to the meeting minutes of September 1898, she and Mrs. Lucas gathered enough money within an hour.

Earlier in August, the regiment had arrived on its way to Manila for the Spanish–American War, along with the official notice Hawai'i had been annexed as a U.S. territory a month ago.

It reported on October 1 about 300 soldiers were attending this Catholic chapel each Sunday, with Mass celebrated by Rev. Father Valentine and a choir of soldiers. The *News Muster* also stated it was "a pretty structure, built of cocoanut leaves" called Camp Gulstan in reference to Bishop Gulstan.

On Thanksgiving Day, the regiment received word the Spanish–American War would likely not need them, then were ordered to return to New York after negotiations were finalized in February.

The chapel's location is currently suspected to have been a bit towards Diamond Head from today's boundaries of Kapi'olani Regional Park.

In September, Company H of this regiment started its own local paper, the weekly *News Muster*, ultimately averaging eighteen-hundred papers distributed weekly. It reporte
